Effective Date: November 1, 2023

The charges for receiving, yarding, feeding, watering, sorting, weighing, selling, and accounting to the consignor for all livestock consigned for sale at CYA Exchange, LLC dba Carrollton Livestock Auction market or otherwise sold on these premises shall be as follows:

Section A. Selling Commission

1. Calves
 - a. up to 249 lbs. \$5.00 per head plus 1%
2. Cattle
 - a. 250-800 lbs. \$12.00 per head plus 1%
 - b. 801-1800 lbs. \$13.50 per head plus 1%
 - c. 1801 lbs. and up \$17.00 per head plus 1%
 - d. Cow/Calf pairs \$17.00 per unit plus 1%
3. Hogs
 - a. Feeder Pigs under 200 lbs. \$5.00 per head plus 1%
 - b. Hogs, Sows, & Boars over 200 lbs. \$8.00 per head plus 1%
4. Sheep & Goats
 - a. All Sheep & Goats \$5.00 per head plus 1%
5. Llamas & Alpacas
 - a. All \$20.00 per head plus 4%
6. Horses, Ponies, & Mules
 - a. All \$20.00 per head plus 4%

Section B. No Sales, Resales, No Value

1. No Sales
 - a. All Full Commission
2. Resales
 - a. All No extra charges are made with respect to resale of animal by original consignor.
3. No Value

Animals deemed at no value will be charged for disposal as follows:

 - a. Cattle and Horses minimum \$200.00
 - b. Calves, Hogs, Sheep, Goats minimum \$50.00
 - c. Ponies, Mules, Llamas & Alpacas minimum \$50.00

Section C. Yardage and Feeding

1. Yardage
 - a. All \$2.00 per head
2. Feeding

Livestock normally are not fed. Feed may be procured at the request of the owner at cost plus 20%.

Section D. Unloading, Weighing, and Loading

A minimum charge for the use of the facilities, labor, and related responsibilities as follows (this does not include "shifting" loads):

- 1. Sale Day (after the sale is completed)
 - a. Cattle and Horses \$5.00 per head, no minimum
 - b. All Others \$3.00 per head, no minimum
- 2. Non-Sale Day
 - a. Cattle and Horses \$5.00 per head, minimum \$50.00
 - b. All Others \$3.00 per head, minimum \$50.00

Section E. Veterinary Services

CYA Exchange, LLC dba Carrollton Livestock Auction is not responsible for loss or damage to livestock resulting from the use of facilities or for the product used for treatment. The market furnishes facilities for veterinary purposes, when requested, for reasonable charges. The schedule of charges on all necessary veterinary services performed by an accredited veterinarian will be posted uniform per head rates, pursuant to company agreement with the veterinarians performing such services and does not contain any charges retained by the market.

Section F. Buying Charges

To offset expenses incurred in soliciting bids from off-the-market buyers, a \$5/head service charge may be assessed to the buyer. (Charge not to exceed one-half the regular service charge listed in this tariff schedule for the specie and class of livestock purchased.)

Section G. Insurance

CYA Exchange, LLC dba Carrollton Livestock Auction does not provide, nor charge, for insurance.

Section H. Special Sales

Special sales will be charged under special arrangements agreed to between the parties prior to the sale. Charges will be made in line with the services rendered.

Section I. Credit Card Buyer's Premium

To offset expenses incurred in accepting credit and debit card payments, a buyer's premium will be assessed to the buyer paying with a credit or debit card. The buyer's premium will be as close to the actual fee charged by the credit card processor as possible for ease of calculation at time of payment.

Section J. Promotion or Check-Off Program Fees

Federal and state laws currently mandate the deduction of check-off funds from livestock sellers' checks for cattle, sheep, and swine. These fees vary from a per-head charge to a weight basis charge or combination. These fees will be deducted from sellers' checks per the current federal and/or state amounts.

Section K. Consignor Services

Deductions to haulers or other designated service providers will be made from sellers' checks as directed by sellers or sellers' authorized representatives.
