Produce

During the summer and fall months, our Endless Treasures sale is overflowing with fresh produce from some of our local farms. As long as they are unprocessed fruits and vegetables, they can be sold at CYA Exchange. We typically start selling produce at 10:30 a.m. We ask that consignors make every attempt to package items uniformly.

Eggs

CYA Exchange is a registered farm market. Your egg operation, if under 500 poultry, does NOT need to be inspected by ODA or your local health department to sell eggs here. Egg cartons must be in sound condition and free from any visible dirt. All cartons must be labeled with your name, address, quantity, date packed into carton, "graded" or "unclassified", "mixed size", and the Safe Handling Instruction phrase.

Cottage Foods

A person producing food that is not considered potentially hazardous foods can sell them during our Endless Treasures sale without any special licensing. These foods must be properly labeled per ODA regulations.

Permitted foods: cookies, breads, brownies, cakes, fruit pies, candy, jams, jellies, fruit butters, granola, popcorn, unfilled donuts, snack mixes, dry baking mixes, dry herbs, and more.

Non-permitted foods: acidified or low acid canned foods (beans, cucumbers, cabbage, puddings, etc.) and potentially hazardous food that requires temperature control (raw animal products, cooked vegetables, garlic in oil, cheesecakes, pumpkin pies, custard pies, cream pies, egg noodles, etc.)

Required labeling: name of the food product, net weight (in both pound system and metric system), ingredient list in descending order of weight, name and address, "This Product is Home Produced."
