Section D. Insurance

CYA Exchange, LLC dba Carrollton Livestock Auction does not provide, nor charge, for insurance.

Section E. Special Sales

Special sales held will be charged under special arrangements agreed to between the parties prior to the sale. Charges will be made in line with the services rendered.

Section F. Credit Card Buyer's Premium

To offset expenses incurred in accepting credit and debit card payments, a buyer's premium will be assessed to the buyer paying with a credit or debit card. The buyer's premium will be as close to the actual fee charged by the credit card processor as possible for ease of calculation at time of payment.

Section G. Consignor Services

Deductions to haulers or other designated service providers will be made from sellers' checks as directed by sellers or sellers' authorized representatives.
